SUBJECT: AFRC Undergraduate Flying Training (UFT) Selection Board 22-05 Results

*** OFFICIAL SELECTION DATE IS JULY 12, 2022 ***

- 1. The individuals listed in the Attachments were selected for Undergraduate Flying Training by AFRC UFT Selection Board 22-05 which convened in accordance with AFMAN36-2100 *MILITARY UTILIZATION AND CLASSIFICATION* (7 APR 21) on 12 Jul 22 at HQ AFRC.
 - a. **For Commander action**: Notify selectees within 7 days of receipt of this message. One week after this message is sent to commanders, it will be forwarded to recruiters, Unit Hiring POCs, and 340 FTG for selectee notification and processing.
 - b. **For Recruiter/Unit Hiring POC action**: Notify selectees immediately upon receipt of this message, and coordinate future gain/in-processing actions.
 - c. For 340 FTG action: Upon receipt of this message, contact selectees (except unit-managed RPA selectees) for gain/in-processing.

2. Administrative notes for selectees:

- a. The 340th Flying Training Group will manage your training (except for RPA selectees, which are unit-managed) and will be in contact with you soon to facilitate your gain into the Air Force Reserve. Be prepared for delays in this process, depending upon training availability.
- b. If you do not have a certified flight physical, work with your recruiter and/or unit to schedule one (be sure to mention your selection on an AFRC UFT Board). Once your flight physical is stamped certified, notify Mr. Gordon Olde via email at gordon.olde.1@us.af.mil. Selectees must have an appropriate Flying Class Physical certified by AETC Surgeon General that is valid through the start date of their training program (ENJJPT, SUPT, URT, UCT and UABMT). All flying class physicals are good for 48 months following the certification date. Some selects have current physicals which will expire before their training start date. It is the member's responsibility to seek a new flying class physical, if required, based on the class start date on their orders. For more

flying class physical information, reference AFI 48-123, Medical Examinations and Standards.

- c. For non-officer selectees, you will attend Officer Training School (OTS). Specific information on OTS is available online at https://www.airuniversity.af.edu/Holm-Center/OTS/. All officer candidates must comply with AFMAN 36-2905, *AF Physical Fitness Program*, upon arrival for training. The 340 FTG will contact you for scheduling.
- d. Selectees without a private pilot's license will be scheduled for Initial Flight Training (IFT). Specific information on IFT is available online at http://www.dossaviation.com/usaf-ift.
- e. Please allow at least 30 days for 340 FTG to contact you to schedule your training. The POC is Maj Christine Wagner (340FTG.UFT.Workflow.1@us.af.mil; 210-652-6107). If you are an RPA select, your training will be managed by your sponsoring unit (vice 340 FTG).
- 3. AFRC convenes UFT Selection Boards quarterly in October, January, April and July. The next regular AFRC UFT Selection Board (23-02) will convene 11 Oct 22. Application deadline is 30 Sep 22. Eligibility criteria are detailed in AFMAN 36-2100. Application instructions can be found in the AFRC UFT Guidebook available for download at https://afreserve.com/downloads/AFRC UFT Guidebook.pdf.
